The Principal Chief Commissioner of CGST & CX, Delhi Zone invites applications for the recruitment of meritorious Sportspersons in the disciplines of Archery, Athletics (including Track and Field events), Badminton, Boxing, Carrom, Chess, Powerlifting, Swimming, Table Tennis, Tennis, Weightlifting and Wrestling for the following post: -

ELIGIBILITY CONDITIONS

1. AGE LIMIT

For Tax Assistant : 18 to 27 years of age.

Relaxation of Age: As mentioned in the DOPT OM F.No.14034/01/2013 Estt.(D) dated 3rd October 2013

Note: Cut-off date for age limit is 31st August 2020.

02. ESSENTIAL EDUCATIONAL QUALIFICATION

- (I) Degree from a recognized university or equivalent.
- (II) Having Data Entry Speed of 8000 key depressions per hour.

Note: Cut-off date for educational qualification is the last date for the receipt of the application

03. NUMBER OF VACANCIES

- (i) Tax Assistants - 3

04. SPORTS ELIGIBILITY

Appointment can be made of a sportsperson considered meritorious with reference to the following criteria:

Sportsperson having represented

- (i) A state or the Country in a National or International Competition in any of the games/disciplines mentioned above

- (ii) Their University in the Inter-University Tournaments conducted by the Inter-University Sports Board in any of the games/disciplines mentioned above
- (iii) The State School Teams in the National Sports/Games for schools conducted by All India School Games Federation in any of the games/disciplines mentioned above
- (iv) Sportsperson who has been awarded National Awards in Physical Efficiency under National Physical Efficiency Drive.

Note: The merit of sportspersons, who fulfill the aforesaid eligibility conditions, shall be considered /decided in the order of preference given above. Further, priority would be given to current players i.e. who have represented in international and national level in the last three years in tournaments of the recognized sports Federations/Associations. The best performances in the Calendar Years (in the descending order) **2020, 2019, 2018, 2017, 2016 and after 01.01.2015** shall be considered for evaluation.

05. EVIDENCE IN SUPPORT OF MERIT IN SPORTS EVENTS/GAMES

Only certificates awarded by the authorities mentioned hereunder will be taken into account as evidence in support of having participated in competitions in any of the above Sports events/Games while considering eligibility of the applicant. The applicant may submit self-attested copies of at least one merit certificate issued by one of the authorities mentioned hereunder along with application: -

S.no.	Competition	Authority awarding certificates
1.	International	Secretary of the National Federation of the game concerned.
2.	National	Secretary of the National Federation or the Secretary of the State Association of the game concerned.
3.	Inter-University Tournament	Dean of sports or other Officer in overall charge of Sports of the University concerned.
4.	National/ Sports/Games for school	Director of Additional/Joint or Deputy Director in overall charge of Sports/games for schools in the Directorate of Public Instructions/Education of the State.
5.	Physical Efficiency Drive	Secretary or other Officer in overall charge of Physical Efficiency in the Ministry of Education and Social Welfare, Government of India.

The applicant should also enclose self-attested copies of their sports merit certificates in their given discipline.

06. The applicant is required to submit the Forms 1, 2, 3, 4 & 5 (whichever applicable) complete in all respects. The specimens of the said Forms are mentioned at Annexure B hereinafter.

07. SELECTION OF THE APPLICANTS

Subject to fulfilling of the qualification at s.no. 2 hereinabove, the applications shall be scrutinized and suitable applicants will be short listed for further selection procedure. For selection, the short listed applicant will be required to appear for proficiency test/sports trials, if required.

Success in the above test confers no right to appointment unless the Department is satisfied after such enquiry as may be considered necessary that the applicant is suitable in all respect for appointment to the post.

09. The applications should reach at the said address on or before **20th October 2020 by 1700 hrs** by post or by hand (**30th October 2020 for applicants domiciled in North Eastern states, Andaman & Nicobar Islands, Lakswadweep, Jammu & Kashmir**)

10. The applicant is also requested to mention on the envelope **"APPLICATION FOR THE POST OF TAX ASSISTANT AND NAME OF THE SPORT/DISCIPLINE"**

11. The applicant shall enclose attested copies of the following certificates **(NO ORIGINALS TO BE ENCLOSED)**:

- (i) Matriculation/SSC or equivalent certificates for proof of age.
- (ii) Certificates of Educational Qualifications as mentioned in para 2 hereinabove.
- (iii) Sports/games merit certificates as mentioned at S.no. 5 above
- (iv) SC/ST/OBC caste certificate.
- (v) Identity proof (copy of PAN card, AadharCard, Driving Licence, Passport, any other identity card issued by Central/State Govt authorities)

12. The applicant must be in possession of the requisite educational qualification for the concerned post, as on the last date of the receipt of the application, in this office.
13. The application should also have latest photograph of the applicant pasted on the application form.
14. Sports persons who are already employed in Central Government or State Government or PSU should submit an NOC from the present employer before the completion of this recruitment/selection process.
15. The selected applicants will be under probation for 2 years or such period as per the extant instructions of the Government of India. The selected applicant will be required to represent the CGST Department, Delhi Zone in the tournaments/meets as decided by this office.
16. The selected applicants will be required to give an undertaking not to apply for Inter Commissionerate Transfer for a minimum period of 5 years.
17. The applicant upon selection will be liable to be posted anywhere in the jurisdiction of Delhi Zone.
18. Applications received after the due date/time will not be entertained under any circumstances.
19. The applications which are incomplete in any respects are also liable to be rejected and no reasons/communication with the applicant will be resorted to in this regard.
20. The eligible applicants will be shortlisted by this office and called for the sports trials/proficiency tests, if required. The date/venue of such trials/tests will be communicated in due course of time.
21. The applicants are advised not to indulge in any form of canvassing which may render them to be rejected at any stage of recruitment process.
22. The Principal Chief Commissioner of CGST & CX Delhi Zone has right to cancel the recruitment process at any stage without assigning any reason.
23. The decision of the Principal Chief Commissioner, CGST & CX, Delhi Zone will be final in all respects.
