(ii) Date of Priority: - As per S.R. 317-P8 of Department of Revenue and Company Law- The determination of seniority is made as under:-

The seniority of qualified officers whether holding a permanent or temporary post, for the purpose of allotment of residences shall be determined by the date of reaching qualifying limit of pay prescribed for each class of residence under these rule.

Provided that if two or more officers have the same seniority, seniority among them shall be determined by the amount of emoluments higher emoluments taking precedence over the emoluments have been drawn in the post held by such officer at the time of application, the longer same allotment will be made by drawal of lots.
