I am directed to state that in exercise of the power conferred on it by Article 324 of Constitution and Section 20B of the Representation of the People Act, 1951, the Commission has deployed Sh. G Vamshi Krishna Reddy, IRS(C&CE): 10 (R-20319) (Mob. No. 7022640740) as Expenditure Observer in General Election to the Legislative Assembly of Delhi, 2025 announced by the Commission vide its Press Note no. ECI/PN/169/2025, dated 07.01.2025 (copy enclosed).

- 2. Under Section 13CC of the Representation of the People Act, 1950 and Section 28A of the Representation of the People Act, 1951, he will be deemed to be on deputation to the Election Commission during the period, he is working as Observer. Working as Observer of the Election Commission he will be subject to the control, superintendence and discipline of the Election Commission with respect to his duties performed as Observer.
- 3. The Observer is entitled for TA/DA as admissible on tour. He will draw TA/DA from his Ministry/Department/Office. The expenditure will be debitable to the Budget grant of his Ministry or Department/Office. He is also entitled to travel by air by any scheduled commercial flight of any airlines. However, whenever he travels by train, it shall be as per his entitled class.
- 4. The Expenditure Observer is also required to go through "Compendium of Instructions on Election Expenditure Monitoring (December, 2024)" available on the ECI website www.eci.gov.in-Compendium of Instructions-Compendium of Instructions on Election Expenditure Monitoring (December, 2024).
- 5. The Expenditure Observer may be informed that-
- (i) He/She is required to upload his/her photograph in the Personal Information Sheet on the Observer portal. This is required for printing of Identity Cards.
- (ii) User id and password for accessing the Observer portal is 'Observer Code' mentioned against his/her name. He/She should change his/her passwords on first login, if he/she so wish.
- (iii) The deployment list indicating the State, District and Constituency is enclosed.

- 6. Expenditure Observer is hereby directed to report to the Constituencies/District Hq. assigned to him on 17.01.2025 and stay in the Constituencies upto date of Poll i.e. 05.02.2025. Further, he will be required to make his last visit to the constituencies assigned to him on 25th day of declaration of results.
- 7. Updated list of Expenditure Observers is being enclosed herewith. You are requested to intimate the newly deployed Expenditure Observer immediately.
